Over the last forty years, the Michigan Coalition to End Domestic & Sexual Violence has represented the voices of survivors, advocates, and our member programs across the state while advocating for systemic change.

- MCEDSV provides training and technical assistance to local domestic and sexual violence agencies. This year we provided over 481 hours of technical assistance.
- MCEDSV houses the Survivor Law Clinic that provides legal representation to survivors.
- We have a revolutionary anti-oppression group, UMOJA, that examines policy, behaviors, language, and systems and questions and assesses institutional barriers that harm less privileged people.
- Our Prevention team leads the nation with innovative violence prevention work and provided over 450 hours of prevention-specific training and technical assistance.
- Our policy team has been able to represent the voices of victims of violence to state and federal legislators as they craft legislation. Our efforts have made sure harmful laws are not passed and ensured that survivors are supported in the process.
- MCEDSV has expanded to offer direct services to support survivors
 of sexual and domestic violence. We operate the statewide Sexual
 Violence hotline (1-855-VOICES4) and Statewide Domestic Violence
 Hotline (1-855-VOICEDV).


