Over the last forty years, the Michigan Coalition to End Domestic & Sexual Violence has represented the voices of survivors, advocates, and our member programs across the state while advocating for systemic change.

- MCEDSV provides training and technical assistance to local domestic and sexual violence agencies. This year we provided over
 - 481 hours of technical assistance.MCEDSV houses the Survivor Law Clinic that provides
 - legal representation to survivors.We have a revolutionary anti-oppression group, UMOJA, that examines policy, behaviors, language, and systems and
 - questions and assesses institutional barriers that harm less privileged people. Our Prevention team leads the nation with innovative violence prevention work and provided over 450 hours of prevention-specific training and technical assistance.Our policy team has been able to represent the voices of victims of violence to state and federal legislators as they craft legislation.
 - Our efforts have made sure harmful laws are not passed and ensured that survivors are supported in the process.

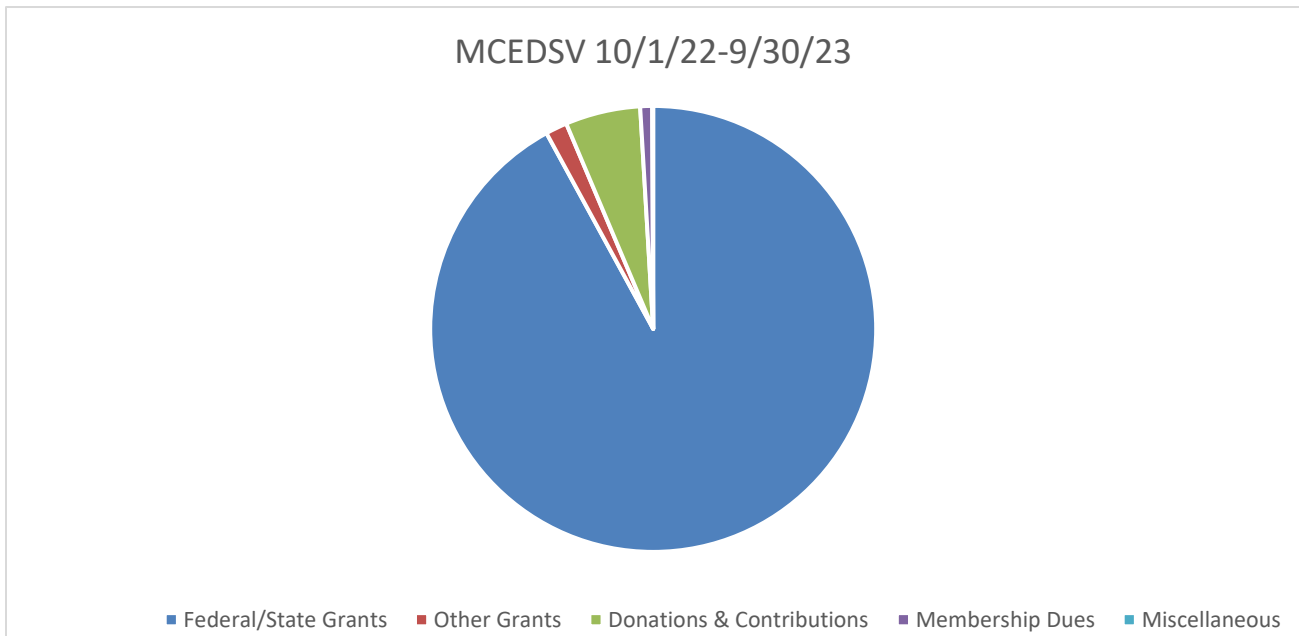
