

# CALL FOR SESSION PROPOSALS MCEDSV 2026 CONFERENCE

## **SESSION FORMATS**

MCEDSV welcomes formats of all styles! Formats can be solo presentations, co-led sessions, panels, storytelling, discussions, creative formats, or something in between. Sessions may be 60 to 90 minutes long. Choose 1 or more of the following formats (you can do more than one presentation!):

- **Day One – Plenary Sessions**  
Focused on shared grounding, collective analysis, and reflection
- **Day Two – Breakout Sessions**  
Designed for deeper dialogue, learning, and exploration
- **Day Three – Applied Sessions**  
Centered on practical skills, tools, and implementation participants can take back to their work



## **PROPOSAL SUBMISSIONS**

MCEDSV's 2026 Annual Conference is all about reclaiming power and uplifting survivors through intentional visioning and sharing of space within community. As you consider submitting a proposal, we invite you to reflect on how your session aligns with one or more of the following values and priorities:

- **Ethical engagement with marginalized communities**
- **Lifting our voices in changing political landscapes**
- **Collective care and sustainability in justice work**
- **Practical tools for ethical leadership and action**
- **Domestic violence/intimate partner violence accountability within community**
- **Survivor-centered human trafficking service provision**
- **Survivor-centered sexual violence response and care**
- **Inclusive and culturally honoring practices.**

Session proposals will include a:

- *title*
- *short description*
- *1 or more of the above-mentioned values and priorities*
- *session format (plenary, breakout, or applied session)*
- *clearly outlined learning goals*
- *presenter bio(s) (a short version is ok for the RFP)*
- *selected learning/experience level of the intended audience*
